Introduction: With financial support from UN Women, ICWEA in partnership with the Alliance of Women Advocating for Change (AWAC) and Uganda Network of Young People Living with HIV (UNYPA) is implementing a community scorecard in 18 districts in Uganda. The community scorecard (CsC) is aimed at building the body of evidence for use in promoting gender equality and women empowerment (GEWE), Sexual Reproductive Health Rights (SRHR) and ending violence against women and girls (VAW/G). The scope of the CsC includes:

- I. Assessing knowledge levels of laws, policies and practices among women living HIV, young people living with HIV and female sex workers.
- 2. Assessing levels of engagement and participation in government programmes by women living HIV, young people living with HIV and female sex workers.
- 3. Assessing availability, knowledge and access to SRHR services and information among women, young people living with HIV and female sex workers

Additionally the evidence is expected to influence the on-going review the National anti-stigma policy, National Development Plan III, Adolescent Health Policy, National HIV strategic plan 2020- and adolescent health policy. The findings will be used to organize dialogues with the duty bearers to promote GEWE, SRHR and end SGBV/ VAWG.
